Artificial Intelligence (A.I.) presents a transformative opportunity to enhance the 360-degree revenue cycle and reimbursement process. From reducing administrative burden, increasing the accuracy of billing and coding, mitigating preventable denials, and even optimizing reimbursement strategies. Leveraging A.I. for these improvements is critical, but often met with scrutiny.

Join leaders from both the provider and payer perspective as they discuss how objective, A.I.-driven insights can align both teams to streamline concurrent authorization handoffs, ensure appropriate reimbursement and reduce the back-end delays associated with avoidable denials. We'll also identify collaboration and impartial automation opportunities that exist between providers and payers.


